# Inspection Authorization Renewal

## SAFETY SEMINAR

SATURDAY, MARCH 3, 2018  
NTSB TRAINING CENTER | ASHBURN, VA



**T**he National Transportation Safety Board is presenting an opportunity for aircraft mechanics to renew their FAA **Inspection Authorization (IA)** at an **NTSB Safety Seminar**. The seminar will be held on Saturday, March 3, 2018, at the NTSB Training Center in Ashburn, Virginia. The Seminar will include eight hours of material designed to increase the participant's knowledge in all facets of the inspection process, as well as lessons learned from the outcome of NTSB investigations.

**Presenters will include NTSB investigators and staff; Federal Aviation Administration (FAA) inspectors; and other industry experts.** Attendees will have the opportunity to not only renew their IA certificate, but also be exposed to presentation material that will encourage attendees to analyze and evaluate the information in an effort to become more informed mechanics and inspectors. Accident case studies involving maintenance issues will be presented by active NTSB investigators and staff, as an opportunity to learn from these often tragic events. Presentations will also include current technology and best practices and procedures for mechanics and inspectors.

## OPTIONAL ACTIVITY:

Attendees will also have the rare opportunity to receive a tutorial briefing on the **TWA 800 accident investigation**, and view the reconstruction.

During this tutorial, attendees will learn how the NTSB conducts accident investigations and the resultant safety

recommendation process. This optional activity will be held at the end of the day and does not count towards the IA renewal.
